This agreement is between *Angela Harrison Photography*, hereinafter referred to as the "Photographer", operating in the Commonwealth of Virginia, and _____, hereinafter referred to as the "Clients", collectively referred to as the "Parties", with the portrait session detailed below. The package list and price list and/or documents to this contract are integral parts of this document. The contract terms, agreement, and price list are the only legally binding documents between the Parties.

Angela Harrison Photography will provide high prints, a limited amount of medium resolution digital photography in .jpeg, .pdf or .png, to clients for Personal and / or Business use on social media. Full photograph ownership remains with *Angela Harrison Photography*. If client wishes to use photography for purposes other than Personal and /or Basic Business use approval must be obtained by Angela Harrison and / or Angela Harrison Photography. At no point is the client permitted to alter the image or remove copyright watermark. For print release the client must contact Angela Harrison Photography unless noted in the details below.

LIABILITIES

Client hereby indemnifies and holds the Photographer harmless against all liabilities, claims, and expenses, including reasonable attorney's fees, arising from Client's use of Photographer's work.

POST-PROCESSING

Post-processing of photos includes advanced color correction, toning, removal of simple blemishes in the portraits.

WEDDING DEPOSIT

It is understood that *Angela Harrison Photography* is the sole paid or unpaid photographer at the event. It is understood that *Angela Harrison Photography* is the exclusive official professional photographer retained to perform the photographic services requested on this contract. Upon signature, *Angela Harrison Photography* shall reserve the time and date agreed upon. A 25% **nonrefundable** deposit is required. Payment can be processed through... 1) PayPal, 2) USPS Mail Angela Harrison Photography, Post Office Box 309, Amelia Court House, VA 23002, 3) with all Major Credit Cards including AMEX. Your deposit applies towards to your total. If for any reason the wedding is rescheduled, canceled your deposit is **nonrefundable**, the remaining amount will be refunded via check within 45 business days.

PHOTOGHERS USE OF IMAGES

Angela Harrison Photography reserves the right to use images created under this contract for advertising, display, publication, or other purposes. The Client signing this contract warrants that he or she has actual authority to agree to the use of the likeness of all persons included in the portrait in this manner and shall indemnify and defend *Angela Harrison Photography* in the event of litigation arising out of such use. Negatives, digital files and previews remain the exclusive property of this *Angela Harrison Photography*.

PHOTOGHERS RIGHTS

Angela Harrison Photography may substitute another photographer to take the photographs in the event of *Angela Harrison Photography* illness or of scheduling conflicts. In the event of such substitution, *Angela Harrison Photography* warrants that the photographer taking the photographs shall be a competent professional. If the *Angela Harrison Photography* cannot perform this Contract due to fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to Photographer's illness or emergency, then the Photographer shall return any deposit or sitting fee to the Client but shall have no further liability with respect to the Contract. This limitation on liability shall also apply if photographic materials are damaged in processing, lost through camera or media malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the Photographer. In the event *Angela Harrison Photography* fails to perform for any other reason, *Angela Harrison Photography* shall not be liable for any amount in excess of all monies paid.

QUALITY OF PRINTING

Client is aware that color dyes in photography may fade or discolor over time due to the inherent qualities of dyes, and Client releases the Photographer from any liability for any claims whatsoever based upon fading or discoloration due to such inherent qualities.
